VOTING BASICS

- Only registered voters may vote.
- **You must show photo identification.**
- When you register, you will be told where to vote, or go on-line: www.michigan.gov/sos
- To make sure you are registered, go on-line to <http://sos.publius.org> or call your city clerk.

TO VOTE, YOU MUST BE:

- Registered to vote at least 30 days before the election.
- U.S. citizen, at least 18 years old by Election Day.
- Resident of Michigan and your city.

ABSENTEE BALLOTS

Contact your City Clerk for an application. You may request an absent voter ballot if you are:

- Age 60 years or older.
- Unable to vote without assistance at the polls.
- Expecting to be out of town on Election Day.
- In jail awaiting arraignment or trial.
- Unable to attend the polls due to religious reasons.
- Appointed to work as an election inspector in a precinct outside of your precinct of residence.

Absentee ballots must be in City Clerk's office by close of polls (8:00 p.m.) on Election Day.
